RELEASE AND WAIVER OF LIABILITY AND INDEMNITY AGREEMENT

IN CONSIDERATION OF being permitted to enter for any purpose any area including, but not limited to, the arena, chutes, staging areas, approaches thereto, and all walkways, concessions, and other areas appurtenant to any area where any activity related to the event shall take place (hereinafter referred to as the "**RESTRICTED AREA**") or being permitted to compete, officiate, observe, work for, or for any purpose participate in any way in the event, each of the undersigned, for him/herself, her/her personal representatives, heirs, and next of kin (hereinafter referred to as "**PARTICIPANT**"):

WARRANTS, acknowledges, agrees, and represents that Participant has inspected, or will do so immediately upon entering and will continuously do so thereafter, the Restricted Area and all portions thereof which Participant enters and with which Participant comes in contact; and Participant **FURTHER WARRANTS** that Participant's entry into the Restricted Area and participation, if any, in the event constitutes an acknowledgement that Participant has inspected the Restricted Area and Participant finds and accepts same as being safe and reasonably suited for the purposes of Participant's use; and Participant **FURTHER WARRANTS** that if, at any time, Participant is in or about the Restricted Area and Participant feels anything to be unsafe, Participant will immediately advise the officials of such and will leave the Restricted Area; and Participant

HEREBY RELEASES, WAIVES, DISCHARGES and COVENANTS NOT TO SUE the promoters, participants, rodeo associations, sanctioning organizations or any subdivision thereof, arena operators, arena owners, officials or any persons in the Restricted Area, sponsors, advertisers, owners and lessees of the premises used to conduct the event, and each of them, their representatives, assigns, heirs, and next of kin (hereinafter referred to as "**Releasees**") for any and all loss or damage, and any claim or demands therefore on account of injury to person or property or resulting in death of Participant, whether caused by negligence of Releasees or otherwise while Participant is in or upon the Restricted Area, and/or competing, officiating, observing, working for, or for any purpose participating in the event; and Participant

HEREBY AGREES TO INDEMNIFY, SAVE, AND HOLD HARMLESS Releasees and each of them from any loss, liability, damage, or cost they may incur due to the presence of Participant in or upon the Restricted Area or in any way competing, officiating, observing, working for, or for any purpose participating in the event and whether caused by the negligence of Releasees or otherwise; and Participant.

HEREBY ASSUMES FULL RESPONSIBILITY FOR AND RISK OF BODILY INJURY, DEATH, OR PROPERTY DAMAGE due to the negligence of Releasees or otherwise while in or upon the Restricted Area and/or while competing, officiating, observing, working, or for any purpose participating in the event.

EACH OF THE UNDERSIGNED EXPRESSLY ACKNOWLEDGES AND AGREES that the activities of the event are very dangerous and involve the risk of serious injury and/or death and/or property damage; and each of the undersigned **FURTHER EXPRESSLY AGREES** that the foregoing release, waiver, and indemnity agreement is intended to be as broad and inclusive as is permitted by the laws of the state or province in which the event is conducted and that if any portion thereof is held invalid, it is agreed that the balance shall, notwithstanding, continue in full legal force and effect.

THE UNDERSIGNED HAS READ AND VOLUNTARILY SIGNS THIS RELEASE AND WAIVER OF LIABILITY AND INDEMNITY AGREEMENT, and further agrees that no oral representations, statements, or inducements apart from the foregoing written agreement have been made.
